Saturday, March 31st at Carl Levin Park in Harker Heights, TX

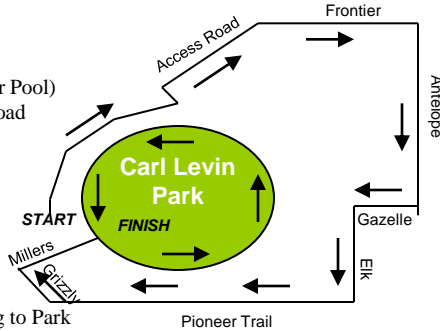
